CIRCULAR No. 03 of 2025

Subject: Levy of Fuel Adjustment Charges (FAC) for the Month of August 2025 in MITL – Shendra Industrial Area.

This circular is issued to inform all concerned consumers regarding the levy of Fuel Adjustment Charges (FAC) applicable for the billing month of August 2025.

MITL Shendra Industrial Area is levying the FAC strictly in accordance with the Multi Year Tariff (MYT) Order issued by the Hon'ble Maharashtra Electricity Regulatory Commission (MERC) dated 28.03.2025. As per the provisions of the MERC (Multi Year Tariff) Regulations, 2024, the distribution licensee is required to recover the variation in power purchase on a monthly basis. For example, the variation in power purchase cost for the month of April 2025 is recoverable through the electricity bill issued for the month of May 2025.

Accordingly, in order to avoid burden on consumers, the variation in power purchase computed for **April 2025** will be recovered through the **August 2025** electricity bill. Similarly, the variation in power purchase computed for **May 2025** will also be recovered through the **August 2025** electricity bill. Further, the variation in power purchase computed for the **June 2025** and **July 2025** will be recovered through the **September 2025** electricity bill and will be informed through separate circular.

It is also to be noted that the post-facto approval from the Hon'ble MERC for the FAC amounts pertaining to the months of April 2025 to June 2025 is under process. Upon receipt of such approval, the applicable FAC will be adjusted and recovered in the forthcoming billing cycles, as per the guidelines laid down by the Hon'ble Commission.

The category-wise and slab-wise FAC towards the month of April 2025 and May 2025 applicable for the recovery in the month of August 2025 has been provided in Annexure – I and Annexure – II attached herewith for reference.
